Called to Order: The meeting was called to order by Commissioner Anthony at 6:00 p.m.

Approval of the Democratic Caucus Minutes:

MOVED BY COMM. BAHAR-COOK, SUPPORTED BY COMM. CELENTINO, TO APPROVE THE MINUTES OF THE JANUARY 28, 2014 DEMOCRATIC CAUCUS MEETING.

MOTION CARRIED UNANIMOUSLY. Absent: Commissioners Crenshaw and Nolan.

Treasurer's Report:

Commissioner Hope reminded the Caucus that the dues of \$75 each are due at their convenience.

Appointments:

Chairperson Anthony asked if there was any continued discussion regarding the potential appointment of Dr. Rex Pierce to the Community Health Center Board despite the fact that he does not reside in Ingham County. Commissioner Tennis stated that the Human Services Committee interviewed all three candidates and despite the residency policy, they decided to recommend Dr. Pierce and the other two applicants for the appointments. Chairperson Anthony stated that there is a resolution regarding these appointments on the agenda for the Board of Commissioners meeting for that evening.
