THE MOTION CARRIED UNANIMOUSLY. Absent: Commissioner Tennis.

THE MOTION TO APPROVE THE ITEMS ON THE CONSENT AGENDA CARRIED UNANIMOUSLY. Absent: Commissioner Tennis.

1. <u>Environmental Affairs Commission</u> – Energy Audit Update

Rick Terrill, Ingham County Facilities Director, provided an executive summary of the Energy Sustainability Project. He further stated that the site visits would begin on Wednesday June 8, 2022 at the Forrest Community Health Center, and continue on June 9, 2022 at Lake Lansing South Park and Burchfield Park.

Mr. Terrill stated that the meeting held on May 3, 2022 with Bureau Veritas (BV) had been very productive and that the BV team had expressed excitement to work with Ingham County. He further stated that he believed that the Commissioners would be pleased to know that BV had gone above and beyond to provide the requested information.

Mr. Terrill stated that there had been discussion regarding the scope and when each level would be warranted or not. He further stated that they ultimately had asked BV to provide a Level 2 American Society of Heating, Refrigerating and Air-Conditioning Engineers (ASHRAE) audit, which would result in significant savings for many of the locations as a Level 3 audit would not be needed.

Chairperson Trubac asked for clarification on what a Level 2 ASHRAE audit included.

Mr. Terrill stated that a Level 2 audit provided a building assessment which included roof, entrances, as well as the mechanical system. He further stated that the Level 2 audit considered improvements that had already been made, as well as how the various areas are occupied.

Mr. Terrill stated that the Level 2 audit had an engineering matrix that reviewed the building usage from a mechanical, electrical and plumbing standpoint. He further stated that a Level 3 audit would have reviewed the replacement cost of a building, which would have involved an engineering study as well.

Commissioner Crenshaw asked for clarification on the energy status of the new Justice Complex.

Mr. Terrill stated that they had worked with a consultant to review the energy efficiencies that could be incorporated with the build. He further stated that they had developed a cladding for the exterior of the building with a vapor barrier on the masonry.

Mr. Terrill stated that that the gap between the exterior of the building and the masonry that would help reduce heat gain and loss. He further stated that the Justice Complex had also looked into two electrical vehicle charging stations that would be installed in the public area.

Mr. Terrill stated that some of the additions would come back to the Board of Commissioners for recommendations and approval.

Commissioner Crenshaw stated that the Youth Center had been included on the list for review. He further stated that the Youth Center was undergoing a Request for Proposal (RFP) to determine its future status.

Mr. Terrill stated that there was a mandatory pre-bid on June 7, 2022 at 10:00 a.m. that would bring consultants in to bid on the project and determine if the site should be renovated or if it would be better suited to build a new facility. He further stated that overall it was not a lot to include the Youth Center in the energy audit, and that it would be a minimum nine month process to receive a recommendation from the consultant.

Commissioner Slaughter asked for clarification on if the HVAC system at the Justice Complex was entirely electric.

Mr. Terrill stated that the Justice Complex had both an electric and hydronic system which utilized natural gas. He further stated that they had the foresight to include as much green initiative into the design, which included retention ponds and green space.

Chairperson Trubac stated his thanks to Mr. Terrill and hoped for an additional update towards the end of the summer.

# 5. Fairgrounds

a. Resolution to Authorize the Purchase of a New Zero-Turn Lawn Mower for the Fairgrounds

MOVED BY COMM. CRENSHAW, SUPPORTED BY COMM. SLAUGHTER, TO APPROVE THE RESOLUTION.

Chairperson Trubac stated that there had been much discussion on the transition to lower emissions. He further asked for clarification if the technology for electric lawn mowers existed.

Lindsey McKeever, Ingham County Fairgrounds Director, stated that she had looked into electric lawn mowers but the three vendors did not have any options available. She further stated that she had been informed that it would be a year or so before any commercial sized options were available.

Ms. McKeever stated that she was aware that Lowes sold electric lawn mowers, however they were only 54 inches. She further stated that the Fairgrounds used 72 inch mowers, which she believed were on the front end of the technology.

Ms. McKeever stated that the Parks Department had a plan to transition from gas lawn mowers, and she would be happy to create a similar plan. She further stated at the moment the Fairgrounds had three lawn mowers, one of which was used for parts.

Chairperson Trubac stated that it sounded like the Fairgrounds was in need of the lawn mowers and could not wait a year for the new technology.

Ms. McKeever stated that she was unsure of when the lawn mower would be available as they would need to place an order. She further stated that she was hopeful to get a new one in the next few weeks.

Commissioner Crenshaw asked for clarification if the Fairgrounds was in need of two lawn mowers.

Ms. McKeever stated that there was a need for two mowers within the next few years.

Commissioner Crenshaw asked if it would be a better price if they purchased two mowers at once.

Ms. McKeever stated that she had not looked into that option.

Chairperson Trubac stated that he would like to see the next one be electric.

THE MOTION CARRIED UNANIMOUSLY. Absent: Commissioner Tennis.

## 8. Youth Commission – Discussion

Commissioner Crenshaw stated that he has served as the liaison to the Youth Commission since 2015 and in that time the Youth Commission had struggled with membership. He further stated that since the COVID-19 Pandemic, the Youth Commission had dwindled down to only three members.

Commissioner Crenshaw stated that the staffing person had previously been moved to the MSU Extension before being moved back around 2018. He further stated that the individual has since resigned to finish her degree in social work.

Commissioner Crenshaw stated that while the Youth Commission was a good idea when it had been created in 2001, he believed that it has since reached its lifetime. He further stated that he believed it would behoove the Board of Commissioners to continue and move the Youth Commission forward.

Commissioner Cahill stated that she was in agreement. She further asked if the next step would be to retire the Youth Commission.

Commissioner Crenshaw stated that they would need to rescind the resolution that established the Youth Commission. He further stated that a new resolution would need to be created if a commission would like to have it reestablished.

Commissioner Naeyaert asked for clarification if other commissions that struggled with membership were also being reviewed.

Commissioner Crenshaw stated that it would be a good idea to review the Boards and Commissions to determine if any others have outlived their purpose.

Chairperson Trubac stated that be believed that the Board Director could provide insight.

Commissioner Sebolt asked for clarification if any of the three remaining members were using the Youth Commission as a resume builder or credit for college. He further stated that he did not want to cut an individual off if they were using the Youth Commission to apply for college.

Commissioner Crenshaw stated that the Youth Commission had met only a few times via Zoom during the COVID-19 Pandemic and competed with sports, work and other activities as well. He further stated that while he believed it was a great idea, the Youth Commission was competing with other youth councils in the community.

Commissioner Cahill stated that it was a good idea that the position had gone to MSU Extension as they had many leadership opportunities. She further stated that it would be a good place to direct any young person to if they were looking to build their resume.

Commissioner Slaughter asked for clarification if there had been any thought on how to creatively connect with young individuals.

Commissioner Crenshaw stated that he had not thought of any, as they had struggled to get any participation for months.

Jared Cypher, Deputy Controller, stated that he had spoken with a 4H parent that had expressed that the Youth Commission was parallel to the 4H program. He further stated that it would be mutually beneficial to build a stronger connection with 4H and recommend any youth that expressed interest to them.

Commissioner Sebolt asked for clarification on the last time that the Youth Commission had made any policy recommendation.

Mr. Cypher stated that the last recommendation came prior to the COVID-19 Pandemic.

Commissioner Cahill asked if the Youth Commission had shadowed the Board of Commissioners.

Commissioner Crenshaw stated that they had come to meetings on occasion, and had even extended invitation to the Commissioners who served on the Human Services Committee. He further stated that it was difficult to engage as both the Youth Commission and the Human Services Committee met at the same time.

Chairperson Trubac asked if changing the meeting time would spark some additional interest.

Commissioner Crenshaw stated that the Youth Commission would still battle conflicts with sports, work and other activities.

Commissioner Naeyaert stated that there were some Boards and Commissions that lacked purpose. She further stated that there were alternative avenues that the Board of Commissioners could become more involved with.

Commissioner Naeyaert stated that it was a sign to end a commission when it became hard to get members to stay and meet.

Chairperson Trubac asked for clarification if a motion was needed to rescind the resolution that created the Youth Commission.

Commissioner Crenshaw stated that it would be best to ask the Controller's Office to prepare a resolution for the next round of meetings to effectively rescind the resolution. He further stated that it would then go before the full Board of Commissioners for approval.

# Chairperson Trubac requested a resolution to rescind the resolution that created the Youth Commission.

9. <u>Controller's Office</u> – Resolution to Authorize an Agreement with Parkwood YMCA Utilizing American Rescue Plan Act of 2021 Funds for an Expansion Project for the Kids Time Preschool Program and Camp Hugabee

MOVED BY COMM. SEBOLT, SUPPORTED BY COMM. SLAUGHTER, TO APPROVE THE RESOLUTION.

Commissioner Crenshaw stated that he had made note of the \$120,000 price tag. He further asked if the architect and engineering work that outlined the costs had been completed.

Casey Thompson, YMCA President and CEO, stated confirmation and noted that the YMCA had worked with Meridian Township as well as the architect to ensure that they were compliant with the licensing regulations for childcare. She further stated that the overall cost might exceed \$120,000, however the YMCA was prepared to cover the difference.

Commissioner Crenshaw asked for clarification if it differed the cost of the membership. He further asked how they intended to pay for the difference.

Ms. Thompson stated that the proposal was intended to specifically increase the enrollment for the Hartwood Preschool. She further stated that while they were a membership facility, it was specifically for the expansion of the facility.

Ms. Thompson stated that it included new bathrooms that were designated for the childcare space. She further stated that the funds would go to the facility buildout and would not offset the payment of any individual.

Commissioner Naeyaert asked for clarification as to why the resolution was late.

Mr. Cypher stated that he had just recently found out that the work needed to be completed by August 15, 2022. He further stated that as a result it moved up the priority list.

Commissioner Naeyaert stated that it doubled the size of the facility, and believed that it was a great thing as childcare was hard to come by.

Commissioner Naeyaert stated that April Brown, AdvisaCare Executive Director, lost her Father in-law suddenly over the weekend.

Jack O' Lanterns Unleashed is returning to the Fairgrounds in October. An overview of the event was provided to the Human Services Committee on April 4, 2022.

At the April meeting, the Human Services Committee requested the following:

## A survey from the ticketholders in 2021

A survey was sent to over 2,500 email addresses on file and a total of 432 responses were received. The survey was short, only asking nine questions. Significant to note, the overwhelming majority of the responses demonstrated a positive experience for visitors, with 65% saying they will return in 2022 and 90% saying they would recommend the event to family and friends.

# A review of the presented ticket prices to ensure the event was priced appropriately

Given the responses from the survey and reduction in the cost of the ticket prices from 2021 to 2022, the Fairgrounds Events Director and Fair Board are recommending the same ticket pricing and structure as was presented at the April Human Services Committee meeting. The ticket prices remain cheaper to purchase online in advance even with the \$1 fee collected by the ticketing company. Tickets can be purchased at the event, and do not exceed \$18 per ticket. In an effort to provide an opportunity for families with a more affordable option, all children up to age 14 will be admitted free of charge October 7, 8, and 9. This is also an effort to attract an age group that was missed in 2021.

## Demographic information from 2021 ticket buyers

In total, purchases were made from 231 unique zip codes. Of the online ticket sales, Lansing zip codes made up 18.5%, Mason made up 13.74%, and Holt made up 6% of sales.

## **Advertising Plan**

The advertising plan for the 2022 event will be multi-media including broadcast television, commercials on streaming apps, digital ads, billboards, and newspaper. A significant portion of the advertising budget will be spent on social media and managed by the Fairgrounds Events Director. Different than in 2021, the 2022 marketing campaigns with WLNS, WILX, and Fox47 will start in October rather than September. In an effort to reach a more diverse audience, there will be ads in the City Pulse, Adelante Magazine, and the Chronical News. According to the survey, most ticket buyers learned about the event on Facebook. Therefore, Facebook will continue to be a significant tool used to promote the event. With paid advertising and utilizing contests to create an organic excitement about the event, Facebook will help to reach the volume of people that is needed to make the event successful.


A more grass roots campaign will be introduced this year as well, demonstrated by a partnership with the Capital Area District Libraries. In exchange for tickets to provide to patrons, the library system will provide email blasts, contests, and other promotions for the event. Additionally, post cards will be given out at the Zoo and Parks entry gates with a QR code and a discount ticket opportunity, as well as a discount ticket opportunity for Ingham County Employees to purchase cheaper tickets to the event. Partnerships with local Halloween events such as Witches on the Town in Mason make sense in providing a mutually beneficial relationship between event organizers. Finally, a significant push to attract students from MSU campus will be made by trying to create a partnership between the Office of Resident Life and the Fairgrounds. If this is successful, there could be an influx of students coming to the event.

Finally, a discount ticket option will be available for groups of over 15 with a \$2 discount per adult ticket while groups of 25 or more will receive a discount of \$4 per adult ticket.



# How did you find out about Jack O' Lanterns Unleashed? 403 responses




# Did you feel the price of the tickets were reasonable?







Ingham County Health Department (ICHD) wishes to accept grant funds from Michigan Public Health Institute (MPHI) for the Advance Peace Project effective June 1, 2022 through September 30, 2022 in an amount not to exceed \$32,721.12.

Through Resolution #21-179, Ingham County Health Department included in its 2022-2024 public safety planning, a commitment, support, and partnership with Advance Peace and local partners in the amount of \$590,000 for establishing a program to help build and sustain local community capacity to interrupt gun violence. This program will help save lives and reduce the life-altering trauma experienced by people living in the impacted communities and by the service providers who support them.

The Advance Peace planning team has established a three-year budget totaling \$1,954,240 for local implementation of the Peacemaker Fellowship® (the flagship program of the Advance Peace model), and has secured commitments for funding totaling \$1,597,405, of which \$32,721.12 was committed via formal notification of the Department of Justice Byrne Grant award from MPHI. ICHD in return, will complete all grant reporting outlined in the contract with MPHI by the required deadlines.

WHEREAS, this program will help save lives and reduce the life-altering trauma experienced by people living in the impacted communities and by the service providers who support them; and

WHEREAS, the Advance Peace planning team has established a three-year budget totaling \$1,954,240 for local implementation of the Peacemaker Fellowship® (the flagship program of the Advance Peace model), and has secured commitments for funding totaling \$1,597,405, of which \$32,721.12 was committed via formal notification of the Department of Justice Byrne Grant award from MPHI; and

WHEREAS, ICHD will complete all grant reporting outlined in the contract with MPHI by required deadlines; and

WHEREAS, the Health Officer recommends that the Ingham County Board of Commissioners authorize accepting the Department of Justice Byrne grant from Michigan Public Health Institute effective June 1, 2022 through September 30, 2022 in an amount not to exceed \$32,721.12.

# **BACKGROUND**

Ingham County Health Department (ICHD) wishes to enter into an agreement with R Statistical Software training for the Community Health Assessment Unit to increase the department's capacity to conduct epidemiologic disease surveillance, effective July 25, 2022 through July 29, 2022 in an amount not to exceed \$9,940. R Software is free and does not require an annual licensing fee in addition to initial training costs and has been identified with expertise in Epidemiology. R Statistical Software training is available in the fiscal year 2022, and is equipped to deliver training onsite at the ICHD. In-person R statistical software training can be delivered by Applied Epi in ten, 3.5-hour modules over five days, beginning July 25, 2022 and ending July 29, 2022.

## **ALTERNATIVES**

The Community Health Assessment Unit team lead has not been able to identify any alternatives for statistical software training provided by experienced Epidemiologists for the specific purpose of epidemiologic disease surveillance.

#### FINANCIAL IMPACT

All costs for this agreement in an amount not to exceed \$9,940, will be funded by COVID-19 Mobile Testing grant.

# **BACKGROUND**

Mason Public Schools requests funding in the amount of \$1,000,000 to support 1.0 FTE nurse, 2.0 FTE school counselors, 1.0 FTE mental health specialist, and 1.0 FTE interventionist. Please see the attached memorandum for more details.

#### **ALTERNATIVES**

Mental health problems, especially for children and youth, have been exacerbated and have become more serious during the COVID-19 Pandemic. The subsequent learning losses associated with mental health problems and its effects have been severe. Substance abuse, behavioral and mental health, and obesity are the primary problems. Anxiety, depression, and even suicidal ideation, related to isolation and fear, have also been associated with the pandemic and have been seen by the mental health providers in Mason Public Schools. Increases in school violence and aggressive behaviors have been linked to the health crisis. Medical problems have been aggravated and have become more serious during the COVID-19 Pandemic as well. This funding will allow Mason Public Schools to address systemic public health and economic challenges that have contributed to the unequal impact of the pandemic. The district will be able to support COVID-19 mitigation efforts, medical expenses, behavioral healthcare, and public health and safety staff.

# RESOLUTION TO AUTHORIZE A CONTRACT WITH MASON PUBLIC SCHOOLS FOR AN AMERICAN RESCUE PLAN FUNDED PROJECT TO MITIGATE THE EFFECTS OF THE COVID-19 PANDEMIC AND SUPPORT THE NEEDS OF MASON PUBLIC SCHOOLS

WHEREAS, H.R. 1319 of the 117<sup>th</sup> Congress, also known as the American Rescue Plan Act of 2021 became law on March 11, 2021; and

WHEREAS, *Title IX, Subtitle M – Coronavirus State and Local Fiscal Recovery Funds* of the American Rescue Plan provides funding to metropolitan cities, nonentitlement units of local government, and counties to mitigate the fiscal effects stemming from the public health emergency with respect to the Coronavirus Disease (COVID–19); and

WHEREAS, eligible uses of the American Rescue Plan funds include:

- (A) to respond to the public health emergency with respect to COVID-19 or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality;
- (B) to respond to workers performing essential work during the COVID–19 public health emergency by providing premium pay to eligible workers of the metropolitan city, nonentitlement unit of local government, or county that are performing such essential work, or by providing grants to eligible employers that have eligible workers who perform essential work;
- (C) for the provision of government services to the extent of the reduction in revenue of such metropolitan city, nonentitlement unit of local government, or county due to the COVID–19 public health emergency relative to revenues collected in the most recent full fiscal year of the metropolitan city, nonentitlement unit of local government, or county prior to the emergency;
- (D) to make necessary investments in water, sewer, or broadband infrastructure; and

WHEREAS, Ingham County is projected to receive \$56,710,344 in American Rescue Plan funds; and

WHEREAS, mental health problems, especially for children and youth, have been exacerbated and have become more serious during the COVID-19 Pandemic; and

WHEREAS, medical problems have been aggravated and have become more serious during the COVID-19 Pandemic as well; and

WHEREAS, Mason Public Schools has submitted a proposal to utilize up to \$1,000,000 of the First Tranche Amount to mitigate the effects of the COVID-19 pandemic and support the needs of the Mason Public Schools; and

WHEREAS, this funding will allow Mason Public Schools to address systemic public health and economic challenges that have contributed to the unequal impact of the pandemic, and to support COVID-19 mitigation efforts, medical expenses, behavioral healthcare, and public health and safety staff.

THEREFORE BE IT RESOLVED, that the Ingham County Board of Commissioners authorizes a contract with Mason Public Schools to utilize up to \$1,000,000 of the First Tranche Amount to mitigate the effects of the COVID-19 pandemic and support the needs of the Mason Public Schools as detailed in the attached proposal.

# **BACKGROUND**

# **Mason Area**

The City of Mason is the county seat of Ingham County and with the surrounding townships makes up the sprawling Mason Public Schools district. The City of Mason has a population of 8,487. The school district, which encompasses the city and its neighboring townships, has a population of over 20,000 residents.

#### **Mason Area Needs**

Mental health problems, especially for children and youth, have been exacerbated and have become more serious during the COVID-19 Pandemic. The subsequent learning losses associated with mental health problems and its effects have been severe. Substance abuse, behavioral and mental health, and obesity are the primary problems. Anxiety, depression, and even suicidal ideation, related to isolation and fear, have also been associated with the pandemic and have been seen by the mental health providers in Mason Public Schools. Increases in school violence and aggressive behaviors have been linked to the health crisis. Medical problems have been aggravated and have become more serious during the COVID-19 Pandemic as well. This funding will allow Mason Public Schools to address systemic public health and economic challenges that have contributed to the unequal impact of the pandemic. The district will be able to support COVID-19 mitigation efforts, medical expenses, behavioral healthcare, and public health and safety staff.

### **Mason Public Schools**

Mason Public Schools has an enrollment of 3,247 students. Almost 28 percent of the students in Mason Public Schools are considered disadvantaged and are eligible for either free or reduced lunches. The school system has limited access to social work services to identify, diagnose, and intervene in student mental and behavioral health problems and has only recently been able to add staff in that area. For the first time in many years, Mason Public Schools has hired a full-time nurse – services that are now, more than ever, needed to diagnose, test, and intervene in cases of COVID-19, contact trace, enforce quarantines, provide information and training relative to illness prevention for students and adults, and set up medical plans for the various other needs of the district's students.

Where mental health and medical services have been lacking in the past, the need for these services has grown and problems have become more serious due to the COVID-19 Pandemic. Attendance is one area where the impact of these problems can be seen. In 2019-20, the last year of typical school attendance reporting and the first year impacted by the pandemic, 15 percent of Mason Public Schools students were chronically absent. This number jumps to 23.2 percent for students with disabilities, 25 percent for students for students who are economically disadvantaged, and 61 percent for students who are homeless.

This need has negatively impacted learning and literacy. Standardized tests are just one measure of learning, but Michigan M-STEP scores declined significantly as a result of the pandemic. For example, in sixth-grade math, 28.6 percent of students tested proficient or above in 2021 in the state, compared with 35.1 percent in 2019, the last time Michigan students took the test. In third-grade math, 42.3 percent of students tested proficient, compared with 46.7 percent in 2019. At Mason Public Schools, this impact on learning can be seen through the percentage of students enrolled in college after graduation. In the first year affected by the pandemic, 2019-20, 56.4 percent of the graduating class was enrolled in college (all types) six months after graduation. This was a 15-point percentage drop from the 2018-19 school year. The drop was similar for economically disadvantaged students at Mason Public Schools as their enrollment in college after graduation dropped from 50.9 percent in 2018-19 to 35.5 percent in 2019-20.

A recent report states that Michigan has the second-lowest student to counselor ratio in the United States. The state's ratio is 671 students to one counselor, according to data from the 2019-20 school year. The American School Counselor Association suggests a ratio of 250:1. Mason Public Schools' current ratio is roughly 650 students to one counselor. When you add in the district's school social workers, who often serve as counseling support, this ratio improves to nearly 300 students to one counselor/social worker. Even factoring in the social work support, this is still well below the suggested ratio of counseling support. This lack of support negatively impacts student mental health and academic achievement.

A final area where the pandemic and lack of student supports has been evident in Mason Public Schools and the state is in school threats, violence, and inappropriate school behaviors. Behavioral data from the first four months of the 2021-22 school year saw a significant increase in inappropriate behavior compared to pre-pandemic numbers. In 2019, there were 300 behavior referrals in grades K-5 in Mason Public Schools from the start of school in August through December. In 2021, there were 495 referrals – a 60 percent increase. Grades 6-12 also saw increases in behavior instances as the number of suspensions significantly grew in the fall of 2021 as compared to the fall of 2019. This funding request will supplement student supports as wells as help fund threat assessments. Threat assessment is intended to prevent violence and involves both assessment and intervention. Threat assessment involves determining whether a student poses a threat of violence. Behavioral threat assessment is a process to be engaged in by a team of stakeholders, including, but not limited to, the positions funded by this proposal.

## **SPECIFIC REQUEST**

Mason Public Schools requests funding in the amount of \$1,000,000 to support 1.0 FTE nurse, 2.0 FTE school counselors, 1.0 FTE mental health specialist, and 1.0 FTE interventionist.

**NOTE:** The primary duties of each of the requested staff members are listed below. Those services that will be a primary focus in year one are designated (\*); those a primary focus in year two (\*\*).

The **NURSE** will provide the following services:

- Identify and re-engage any students who have sporadic attendance following the year of COVID-19 interrupted education (\*)
- Design programs to increase health care capacity as it relates to viruses and specifically to COVID-19

- Provide an efficient and effective process for increased rapid COVID-19 testing for students and staff (\*)
- Provide for a longer-term, permanent, rapid testing clinic to mitigate the effects of COVID-19 (\*\*)
- Provide contact tracing of any students or teachers testing positive for COVID-19 or one of its variants (\*)
- Establish electronic records to provide data to the Superintendent or his designee(s) regarding the extent of exposures and number of treatments for COVID-19 and COVID-19-related illnesses in the schools
- Help ensure district compliance to all current and future MIOSHA, OSHA, MDHHS, and ICHD guidelines related to COVID-19
- Guide and ensure quarantine of school members testing positive for COVID-19
- Expand health assessment capabilities, screenings, and outreach in the schools establishing a routine schedule for sustainability of these services (\*\*)
- Support students and families that are experiencing COVID-19-related illnesses
- Explore and advise the superintendent on the use of telehealth services for triage and response to illnesses
- Establish creative and sustainable community education programs that encourage public health and safety
- Work with district officials to assure compliance with the medical needs of Section 504 plans
- Help coordinate and serve on district and building-level emergency/crisis management teams
- Revise district crisis, emergency, and health management manuals and plans
- Help develop and implement threat assessment procedures that are clearly communicated to staff and families

# The **COUNSELORS and MENTAL HEALTH SPECIALIST** will provide the following services:

- Establish an on-going, robust, and sustainable assessment program (K-12) to identify, diagnose, and prescribe interventions for students experiencing behavioral, substance abuse, and mental health problems, especially, problems that have resulted from the effects of isolation, anxiety, and fear during the COVID-19 pandemic (\*\*)
- Work with the nurses, advise families, students, and staff on nutritional needs and complications resulting from pandemic-related depression or anxiety
- Support teachers who are coping with their own mental health issues resulting from disruptions to the educational process; (\*)
- Support teachers as they implement prescribed behavioral or mental health interventions in their classrooms;
- Work with groups of students to provide support and interventions for anxieties or fears related to the pandemic, for problems because of the greatly expanded use of communication technologies during this period, and problems caused by critically reduced socialization with peers and adults; (\*)

- Work with students who have suffered setbacks in academic performance caused by pandemic-related disruptions to the educational process
- Engage volunteer mentoring and tutorial services to support student academic, behavioral and mental health needs; Note: If seniors are engaged in providing these services to the students, the results may show benefit to the children, youth, AND the seniors as well.

- Provide and expand education for teachers and parents regarding early identification of mental health, behavioral, and substance abuse problems in youth and provide them with school and community resources for support. (\*\*)
- Help develop and implement threat assessment procedures that are clearly communicated to staff and families
- Participate on a multi-disciplinary threat assessment team of trained professionals, including school mental health professionals, administrators, and local law enforcement

# The **INTERVENTIONIST** will provide the following services:

- Diagnoses, assesses, prescribes, and evaluates the reading and/or math needs of individual students to determine level of need, especially as students return to full inperson learning as a result of the COVID-19 pandemic (\*)
- Carries out ongoing assessment of reading and/or math needs; writes and modifies the lesson plans as needed; maintains student achievement records
- Consults with other content teachers, special education teachers, parents and students, advising on strategies and activities that may be used to enhance a student's reading and/or math skills
- Teams with content area teachers and special education teachers to plan and instruct strategies, activities, and units that enhance students' reading and/or math skills
- Maintains a print-rich classroom
- Participates in regular professional development to improve personal knowledge and skills

# **COMMUNITY IMPACT**

If granted, the requested funds will significantly increase services and resources to students in Mason Public Schools to the Mason area in general and, indirectly, to the families of the students receiving these services.

# STRATEGIC PLAN

This proposal supports the overarching health and academic plan of Mason Public Schools to provide more primary care services through the schools, enhance mental health care for the community, and support literacy and learning impacted by the ongoing COVID-19 Pandemic.

If the Board of Commissioners is able to fund the proposal for the two-year period outlined below, Mason Public Schools is confident the district will be able to sustain the added positions for the 2024-2025 school year and beyond through the use of future per pupil funding increases. The district also has additional funding and grants that may be used to sustain these positions.

**RESOLUTION:** That the Ingham County Board of Commissioners authorizes an appropriation of \$1,000,000 from the American Rescue Plan Act of 2021 to mitigate the effects of the COVID-19 pandemic and support the needs of Mason Public Schools for the 2022-23 and 2023-24 school years.
