Commissioner Tsernoglou entered the meeting at approximately 6:02pm.

DISCUSSION REGARDING COMMITTEE ASSIGNMENTS

Discussion ensued regarding committee assignments and who would chair the Planning & Community Outreach and Budget & Personnel Committees. Current members of committees opted to remain on their respective committees. New members were assigned as follows: Michael Rice was assigned to the Planning & Community Outreach Committee and Jonathan Schelke and Kevin Duffy were assigned to the Budget & Personnel Committees. Both current chairs, John Czarnecki and Ralph Monsma, of the committees agreed to remain as chair of their respective committees. In addition, it was determined the Budget & Personnel Committee would continue to meet on Tuesdays, but the meeting would be held at noon instead of 6:00pm.

ACTION ITEMS

Discussion ensued regarding the proposed resolution amending Parks Resolution #33-09 limiting smoking within the Ingham County Parks System and establishing designated smoking areas. Willis Bennett provided background information regarding the resolution. Mr. Czarnecki stated he wants a smoke free park and will work towards that in the next year. Matt Bennett proposed adding the pathway that goes around Hawk Island to the no smoking areas. Willis Bennett stated staff would rework the resolution and bring it back next month.

Because the packet was copied incorrectly, and the resolution recommending an amendment of Board of Commissioner Resolution #02-285 approving the implementation of a low income park fee policy was absent from the packet, a decision was made to bring it to the April meeting.

Willis Bennett provided background information regarding the proposed resolution recommending changes/increases to various Ingham County Park fees. He further indicated he is waiting for the snow park fee structure until the end of the season. Mr. Czarnecki thanked staff for the new ideas and indicated new revenue sources will be important in the future.

RESOLUTION #06-13 ~ RECOMMENDING CHANGES/INCREASES TO VARIOUS INGHAM COUNTY PARK FEES

WHEREAS, in May of each year the Ingham County Board of Commissioners reviews and updates various fees for county services based on information and recommendations of the Maximus Cost of Services Analysis completed in 2002; and

WHEREAS, after reviewing the input from the affected offices and departments, the Controller/Administrator makes final recommendations to the Board of Commissioners; and

WHEREAS, the fee changes below are based on calculations and recommendations from the Budget Office; and

Mr. Czarnecki provided background information regarding the resolution approving the 2014 Ingham County Parks Department 508 Enterprise Fund budget request and stated there was no revenue slated for the Lake Lansing Park-South house in 2014 as staff is currently looking into ADA compliance requirements.

RESOLUTION #07-13 ~ APPROVING THE 2014 INGHAM COUNTY PARKS DEPARTMENT 508 ENTERPRISE FUND BUDGET REQUEST

WHEREAS, the Ingham County Parks Department staff and the Ingham County Parks and Recreation Commission have considered the enterprise fund activities and services for the Ingham County Park System for the year 2014; and

WHEREAS, this resolution represents an enterprise fund revenue budget of \$322,900 and expenses of \$315,900 with an anticipated addition to the 508 enterprise fund, fund balance of \$7,000; and

WHEREAS, these amounts are considered necessary to maintain current service levels to the public, including operation and maintenance costs of facilities and equipment and adequate staffing to provide continued focus on customer service and public safety; and

WHEREAS, the Parks Commission and Parks Staff recognize that expenses cannot exceed the associated earned revenues if the fund and activities are to be sustained, and

WHEREAS, the Parks Commission and Parks Staff recognize that the 508 enterprise fund, fund balance must be maintained at a level adequate to provide funding for the repair and replacement of equipment and facilities into the future.

THEREFORE BE IT RESOLVED, that the attached 2014 Parks 508 Enterprise Fund Budget be approved for adoption in accordance with all appropriate County Policies and Procedures.

Moved by Mr. Czarnecki and **Supported by** Commissioner Koenig that Resolution #07-13 be approved. **Yes-8**; **No-0**. **MOTION CARRIED.**

Mr. Czarnecki spoke regarding the resolution recommending an increase in boat launch fees for 2013. Commissioner Tsernoglou clarified that it is the senior rate that is being eliminated. Mr. Czarnecki stated he is a big proponent of this change.

RESOLUTION #08-13 ~ RESOLUTION RECOMMENDING AN INCREASE IN BOAT LAUNCH FEES FOR 2013

WHEREAS, the Ingham County Parks Department owns and operates the boat launch on Lake Lansing; and

WHEREAS, the user fees at the boat launch offset the cost to properly staff and maintain the facility; and

WHEREAS, the fee schedule for launching watercraft at the boat launch has not been revised since 1999; and

WHEREAS, in order to continue to provide appropriate facilities and services at the boat launch park staff recommends the fee schedule be revised to meet the rising costs associated with the operation of the Lake Lansing Boat Launch; and

WHEREAS, department staff wishes to align the boat launch fee structure with other park fees that do not include a senior rate; and

WHEREAS, the changed fee structure will result in approximately \$5,000 of additional revenue in the 508 Enterprise Fund which is needed to balance the 2013 budget; and

WHEREAS, Parks Resolution #23-03 approved the implementation of a no cost low income boat launch pass available through Capital Area Community Services for individuals who provide proof of eligibility for Medicaid or Supplemental Security Income (SSI).

BE IT THEREFORE RESOLVED, that the Ingham County Parks and Recreation Commission recommends the Ingham County Board of Commissioners approve the fee schedule for launching a watercraft at the Lake Lansing Boat Launch at the rate of \$5.00 for all daily passes and \$50.00 for all annual passes.

BE IT FURTHER RESOLVED, that rates for seniors be eliminated and the new fee schedule be implemented upon adoption of the resolution by the Board of Commissioners.

Moved by Mr. Czarnecki and **Supported by** Commissioner Koenig that Resolution #08-13 be approved. **Yes-8**; **No-0**. **MOTION CARRIED.**

Discussion ensued regarding the resolution supporting the Friends of Ingham County Parks. Mr. McIntosh stated this resolution solidifies the role of the Friends and the relationship between the Parks and Friends organization. Mr. Czarnecki stated this is an excellent idea and more and more we have to look to organizations like this. In addition, he thanked the Friends for their work and contributions to the parks. Mrs. Fraser introduced Karen Surdenik as a new Friends board member and spoke regarding her company's recent \$4,000 contribution to the parks. Ms. Surdenik talked about the upcoming Michigan Corporate Challenge and encouraged everyone to participate. Discussion ensued regarding appointing a park commissioner to the Friends board. It was decided this appointment will be made at a later date.

RESOLUTION #09-13 ~RESOLUTION SUPPORTING THE FRIENDS OF INGHAM COUNTY PARKS

WHEREAS, the Friends of Ingham County Parks were incorporated in September 1999; and

WHEREAS, the Friends of Ingham County Parks organization was created to partner with the parks department, in order to engage the community and to guarantee a vibrant network of parks, recreation and leisure programs critical to healthy, livable communities; and

WHEREAS, the Friends of Ingham County Parks, with the guidance and support of Parks staff, have effectively delivered funding for playgrounds, a band shell, land purchase, wheelchairs, stewardship efforts, sidewalks, band shell concerts, disc golf and more; and

WHEREAS, given the financial need presented by Ingham County Parks Department staff, the Friends have willingly offered to seek general financial support to assist the parks; and

WHEREAS, the Friends of Ingham County Parks Board is a volunteer group of enthusiastic individuals who contribute a diverse set of skills, as well as personal and professional life experiences; and

WHEREAS, the Friends Board of Directors has set forth a multifaceted fundraising strategy for 2013 to include cash and in-kind contributions, utilizing their 501 (c) 3 status to raise a minimum of \$20,000 to support park programs and operations; and

WHEREAS, this effort will include coordinated outreach and solicitation of corporate sponsors, grant applications, Friends sponsored events in the parks, park based fundraising activities, use of social media fundraising tools, and contributions by individual donors; and

WHEREAS, staff support has been and continues to be a necessary part of the success of the Friends of Ingham County Parks; and

WHEREAS, the Friends will on a monthly basis provide a report to the Parks Commission regarding recent actions taken and activities; and

WHEREAS, the Friends are requesting a Park Commissioner participate in and attend Friends of Ingham County Parks Board meetings.

THEREFORE BE IT RESOLVED, the Ingham County Parks Commission supports and appreciates the work and commitment of the Friends of Ingham County Parks.

BE IT FURTHER RESOLVED, that the Ingham County Parks Commission will appoint a Parks Commissioner to the Friends of Ingham County Parks Board.

BE IT FURTHER RESOLVED, that the Ingham County Parks Commission directs Park staff to continue its support of the Friends of Ingham County Parks.

Moved by Commissioner Koenig and **Supported by** Matt Bennett that Resolution #09-13 be approved. **Yes-8**; **No-0**. **MOTION CARRIED.**

Mrs. Fraser spoke regarding the resolution authorizing the distribution of wine at the proposed "Cuisine and Carousels" Friends of Ingham County Parks event at Lake Lansing Park-South. She stated this is a new project for the Friends. In response to Commissioner Tsernoglou's question, Mrs. Fraser indicated the carousel part of the event is in response to a huge interest shown on the Facebook in old carousel pictures. Chair Nicholls said the Michigan Culinary Tourism representative could be of some assistance with an event such as this and if it could align with Pure Michigan and be an all Michigan products event it would be a great thing. Matt Bennett asked who carried the liability insurance and Mrs. Fraser indicated the Friends have liability insurance and the county insurance would factor in also. In response to Matt Bennett's question regarding how the County felt about these type of events and the associated liability, Willis Bennett stated because we have a very strong risk management component with special events we have very stringent insurance requirements.

RESOLUTION #10-13 ~ RESOLUTION AUTHORIZING THE DISTRIBUTION OF WINE AT THE PROPOSED "CUISINE AND CAROUSELS" FRIENDS OF INGHAM COUNTY PARKS EVENT AT LAKE LANSING PARK-SOUTH

WHEREAS, the Friends of Ingham County Parks have demonstrated a commitment to providing support to the Ingham County Parks through multiple fundraising efforts over more than a decade; and

WHEREAS, the Friends of Ingham County Parks organization was created to partner with the parks department, in order to engage the community and to guarantee a vibrant network of parks, recreation and leisure programs critical to healthy, livable communities; and

WHEREAS, the Friends of Ingham County Parks have for a decade coordinated and provided funding through its Lake Lansing Band Shell Committee for Free Friday evening concerts at the Lake Lansing Band Shell; and

WHEREAS, the Friends are planning an event called "Cuisine and Carousels" at Lake Lansing Park South in the summer 2013; and

WHEREAS, this upscale event is intended to attract past contributors to the Friends of Ingham County Parks and will include; food, music, a silent auction, and the sale of wine in original containers of 2 liters or less in a designated secure area to park visitors 21 years or older; and

WHEREAS, the Friends of Ingham County Parks will follow all requirements of the Michigan Liquor Commission and the Ingham County Parks Special Event Policy.

THEREFORE BE IT RESOLVED, that the Ingham County Parks and Recreation Commission approves the Friends of Ingham County's request to sell or serve wine, in original containers of two liters or less, at the "Cuisine and Carousels" event scheduled to be held in the summer of 2013 at Lake Lansing Park-South in compliance with existing park rules and regulations and the requirements of state law.

Moved by Mr. Czarnecki and **Supported by** Paul Pratt that Resolution #10-13 be approved. **Yes-8**; **No-0**. **MOTION CARRIED.**

Mrs. Fraser provided background information regarding the resolution approving the Friends of Ingham County Parks' request to enter into agreements with various vendors for services at Friends sponsored events or activities. She stated this resolution would allow the Friends to put events together in a timely fashion and leaves a clear trail of who is responsible for what. Mr. Czarnecki applauded this effort and stated it is a good idea in order to raise revenue and this is a logical way to go. He looks forward to future events. Commissioner Koenig is worried about the name of the group and wants everyone to be conscious in their dealings to clarify it is the Friends of Ingham County Parks sponsoring and running events and contracting with vendors.

RESOLUTION #11-13 ~ RESOLUTION APPROVING THE FRIENDS OF INGHAM COUNTY PARKS' REQUEST TO ENTER INTO AGREEMENTS WITH VARIOUS VENDORS FOR SERVICES AT FRIENDS SPONSORED EVENTS OR ACTIVITIES

WHEREAS, the Friends of Ingham County Parks organization was created to partner with the parks department, in order to engage the community and to guarantee a vibrant network of parks, recreation and leisure programs critical to healthy, livable communities; and

WHEREAS, the Friends of Ingham County Parks have demonstrated a commitment to providing support to the Ingham County Parks through multiple fundraising efforts over more than a decade; and

WHEREAS, all funds generated by the Friends of Ingham County Parks go directly to the Ingham County Parks for special projects, general support or programming;

WHEREAS, the Friends are requesting the ability to organize and contract with licensed "Food Truck" type businesses or other vendors for services, selling of products, or to participate in Friends sponsored events or activities; and

WHEREAS, the Friends Board of Directors will determine a process whereby the various event planning committees shall select appropriate vendors for said event.

THEREFORE BE IT RESOLVED, that the Ingham County Parks and Recreation Commission approves the Friends of Ingham County's entering into agreements with licensed vendors to provide services or sell products at Friends of Ingham County Parks sponsored events and activities.

Moved by Matt Bennett and **Supported by** Paul Pratt that Resolution #11-13 be approved. **Yes-8**; **No-0**. **MOTION CARRIED.**

DISCUSSION ITEMS

<u>February Parks Financial Report</u> – Mr. Czarnecki reported that parking and revenue are up due to the weather and Willis Bennett stated staff is watching every penny and looking for ways to minimize and economize.

DIRECTOR'S REPORT

<u>Monthly Grant Status Report</u> ~ Willis Bennett reported the snow park is still wide open with 4 feet of snow. The Terrain side of the park will stay open through the first weekend of April for spring break. Commissioner Koenig encouraged advertising this. In response to Commissioner Koenig's question, Willis Bennett stated he felt it had been a very successful season with only minor injuries. He further stated it has been a struggle for the employees working, however the cutting edge work completed by Superparks provided mid-Michigan residents with a changing culture for users and ways to provide lessons and rentals will be in place next year to get the youngsters started early.

EATON & CLINTON COUNTY PARK DIRECTORS – REGIONAL PARKS DISCUSSION

Mason City Administrator Marty Colburn, Eaton County Park Director John Greenslit, Clinton County Parks and Green Space Commission Coordinator Jerry Jaloszynski, and Eaton County Park Commission Members Bob McConnell and Shane Powers introduced themselves and provided background information regarding their park systems.

Mr. Powers stated the DNR is looking for regionalism and considers it as a priority when rating grant requests. He further stated he is very involved in the parks and the Crandall Lake Project is a personal project. Mr. Czarnecki stated counties and communities are competing for young people to stay or relocate here and residents need to step forward and support parks. Mr. Greenslit stated Fox Park is successful and future grants with the DNR will require a "hardship pass" process for DNR grants. Without that grants won't score in that particular category. Mr. Czarnecki stated that at a future meeting Huron-Clinton Metro Parks representatives will be invited to a meeting and he hopes Mr. Greenslit and Mr. Jaloszynski will return for the discussion.

Mr. Czarnecki left the meeting at 7:16pm.

Mr. Jaloszynski said he has been in the field for 37 years, believes regionalism is the way to go, and is amazed no one has gone in that direction. He handed out a document detailing Clinton County Parks and Green Space Commission's History & Goals/Objectives. He further indicated that his County board, even in this financially difficult time, is committed to the Phase II development project for Motz County Park, and he thinks the project will come to a positive end. In addition, they are providing trail monies for a trail initiative and he is working on a non-motorized trail that will come to a conclusion this year.

Mason City Administrator Marty Colburn reported the Mason Recreation Plan was recently finished and they are identifying a path from Delhi to Mason that will come to fruition this year. He stated Mason parks are opening on April 1st and they are 70% finished with the Rayner Park band shell stage. He further stated they are 3 years into the lease with Ingham County and all is going well. It has been a daily challenge to get through different mindsets to find ways to bring people together and find solutions to various issues, but the successes such as Rayner Park are positive. He looks forward to working together and moving forward with advocacy groups.

Mr. Greenslit said recognition of volunteers is important and they have recognized 20 to 25 people in front of their Board of Commissioners a year and people really appreciate it. He further stated he feels he is paid to be an advocate of the parks system. Mr. Greenslit further spoke regarding the DNR Trust Fund and how it is in danger of being dismantled in favor of roads, bridges, and harbors.

All members present voiced their opinions and stated partnering with other communities/counties is the future of parks. Willis Bennett thanked everyone for coming and speaking to the Parks Commission. Chair Nicholls thanked everyone once again and said she just assisted with a 5 year tourism plan for Michigan and trying to build a tri-county tourism product would be of great benefit for all three groups.

RESOLUTION AMENDING PARKS RESOLUTION #33-09 AND DESIGNATING SMOKING AREAS WITHIN THE INGHAM COUNTY PARKS SYSTEM

WHEREAS, Parks Resolution #33-09 prohibited smoking within 100 feet of children's play areas, beach areas, concession areas in all parks and the Splash Pad® area at Hawk Island Park; and

WHEREAS, the Ingham County Parks Commission supports the Parks and Recreation industry's efforts in promoting smoke free parks throughout the country which provides for a healthier, cleaner and safer environment for all visitors; and

WHEREAS, visitor comments and requests indicate support for discouraging smoking within the County Parks system.

THEREFORE BE IT RESOLVED, that the Ingham County Parks and Recreation Commission recommends that, in accordance with Section 3, Paragraph B, of the County Ordinance governing the Ingham County Parks rules and regulations, smoking is prohibited within all Ingham County Parks except within designated areas.

THEREFORE BE IT FURTHER RESOLVED, that the designated smoking areas shall consist of the parking areas within any Ingham County Park and a designated area within the maintenance storage areas located in each park.

THEREFORE BE IT FURTHER RESOLVED, that this resolution becomes effective November 1, 2013 and that signs be installed in appropriate locations indicating smoking is prohibited within that designated area.

BE IT FURTHER RESOLVED, the Ingham County Fair will provide space in their Fair Booklet, advertising the Ingham County Parks and as a part of this advertisement, a coupon will be included for use at any Ingham County Park, offering \$1.00 off refreshments from any Parks Department operated food concession.

RESOLUTION AMENDING RESOLUTION #06-13 RECOMMENDING CHANGES/INCREASES TO VARIOUS INGHAM COUNTY PARK FEES IN 2014

WHEREAS, in May of each year the Ingham County Board of Commissioners reviews and updates various fees for county services based on information and recommendations of the Maximus Cost of Services Analysis completed in 2002; and

WHEREAS, at the Parks & Recreation Commission's March meeting 2014 fees were reviewed and recommended to the Controller/Administrator and the Budget office for approval; and

WHEREAS, the bulk of special events are processed in April and May and staff has determined the amount of administrative time involved in the collection of the special event fee is cumbersome and inefficient; and

WHEREAS, currently special events are not charged for the use of the shelter for their events; and

WHEREAS, staff has determined the special event fee process can be streamlined by charging groups for the shelters needed based on their proposed attendance vs a special event fee charge; and

WHEREAS, staff researched the difference in revenue which would be collected for shelters fees vs special event fees and the difference was less than \$300; and

WHEREAS, the Budget Office has indicated there is time to change this fee before it is forwarded to the Board of Commissioners; and

WHEREAS, because special event fees support the 208 General Operating Fund for the Parks, staff recommends annually transferring shelter fees revenue generated from special events be transferred from the 508 Fund to the 208 fund.

BE IT THEREFORE RESOLVED, the Ingham County Parks & Recreation Commission recommends the Board of Commissioners authorize the elimination of the current special event fee schedule in 2014.

BE IT FURTHER RESOLVED, staff is directed to annually transfer shelter fees generated by special events from the 508 Fund to the 208 Fund.

Meeting of April 22, 2013 **RESOLUTION # -13**

RESOLUTION RECOMMENDING AN AMENDMENT OF BOARD OF COMMISSIONER RESOLUTION #02-285 APPROVING THE IMPLEMENTATION OF A LOW INCOME PARK FEE POLICY

WHEREAS, Board of Commissioner Resolution #02-285 approved the implementation of a Low Income Park Vehicle Fee Policy and Resolution #12-157 amended the Low Income Park Vehicle Policy limiting the policy to Ingham County Residents only; and

WHEREAS, this resolution provides a free daily pass to Ingham County residents who sign a form listing their name, address, and state that paying the vehicle fee would be a hardship, a free annual pass is then mailed to the address listed on the form; and

WHEREAS, it is the intention of the Parks & Recreation Commission to continue this policy that provides entry into Ingham County Parks regardless of ability to pay; and

WHEREAS, it is known that no criterion has been established to verify the financial need of individuals seeking service under the Low Income Park Vehicle Policy; and

WHEREAS, the Parks & Recreation Commission wishes to establish a standard for determining the eligibility of people receiving a fee waiver under the Low Income Vehicle entrance Fee Policy.

THEREFORE BE IT RESOLVED, the Parks & Recreation Commission recommends the Board of Commissioners approve amending Board of Commissioner Resolution #02-285 to require individuals requesting benefits under the Low Income Park Vehicle Policy to provide verification of financial need.

BE IT FURTHER RESOLVED, that modes of verification may include a card such as a Bridge Card, Social Security Supplemental Security Income (SSI) card or other documentation from a Social Service Agency, a MI Health Card, or a State Disability Assistance (SDA) card.

BE IT FURTHER RESOLVED, that daily passes will continue to be made available free of charge through agencies recognized by the Ingham County Board of Commissioners and the Ingham County Parks & Recreation Commission as serving low-income residents.

BE IT FURTHER RESOLVED, that park staff is directed to continue to identify additional avenues of low income verification.

2014 STRATEGIC PLANNING BACKGROUND INFORMATION

1. What changes or events are occurring in county, regional, state, or national matters that can be identified as impacting the services your department delivers?

The recessionary state of the economy in general, home foreclosures and job loss are impacting visitors to Ingham County Parks and the population as a whole. Decreased funding will impact the Parks Department ability to deliver services as operational costs rise.

Available federal grant funds are trending downward. State funds are stable through the Michigan Department Natural Resources Trust Fund as those monies are protected from other use; however these funds are primarily for development and land acquisition. Increased funding is available in the form of the Recreation Passport Grant that can provide funding for new projects, but mainly focuses on maintenance of existing facilities.

Recreational trends nationwide indicate that public parks play a key role in supporting healthy and active lifestyles. The aging baby boomer population is placing added demands on public parks. This generation of adults as opposed to their parents or grandparents is using recreational facilities later in life. Outdoor recreation plays a significant component in physical fitness which is a major focus of preventative medical care.

Improving our alignment with the Greater Lansing Convention and Visitors Bureau and the 2012-2017 Michigan Tourism Strategic Plan will strengthen the Parks Department role in the community and tourism and recreation industry. The Michigan Tourism Strategic Plan includes eight key areas all of which are relevant to county parks:

- Collaboration, Cooperation and Partnerships
- Funding
- Product Development
- Promotion, Marketing and Communications
- Public Policy and Government Support
- Research and Technical Assistance
- Resources and Environment.
- Service Excellence.
- 2. Will these changes affect your department's ability to advance the County's objectives or areas of priority? How will your department's plans for service delivery be affected in 2014 and beyond?

Providing recreational opportunities has long been a goal of the Ingham County Board of

Commissioners. The result of that support is a county park system that stands out as one of the best in the State of Michigan. Negative economic impacts will affect staffing levels, the overall quality of the parks and decrease customer satisfaction and the safety of visitors.

A reduced 2014 parks budget will result in few choices beyond full time staff reduction. Staff will continue to actively pursue options for reducing expenses that correlate directly to park maintenance, amenities provided, and customer service and customer expectations. As maintenance of our parks facilities is decreased and facilities age, public safety will become a significant concern. Maintenance standards of existing facilities will be negatively affected by a decreased budget or reduced staff.

In addition staff will look at functions to seek efficiencies that can be gained through streamlined processes, careful research in regard to product purchases and ways to decrease energy use.

Other considerations could include reduced park and office hours, possibly closing the parks for one – two days per week, eliminating amenities such as fish stocking, elimination of free shelters for school groups and youth oriented non-profits, elimination of activities in the 508 enterprise fund that consistently operate at a loss such as boat rentals and food concession.

3. What major goals does your department hope to accomplish in the 2014 budget year? Do you plan to enhance or reduce any of your department's services?

A significant goal as we look toward 2014 is educating Ingham County's residents regarding budget issues and financial need. Secondly, maintaining appropriate staffing and maintenance levels in the parks to assure the safety of park visitors and a positive visitor experience.

Lastly, continuing to build upon an already successful Friends of Ingham County Parks group (Friends). This group has contributed over \$600,000 to the parks in the last decade. Historically, much of the focus was project related such as the playground at Hawk Island Park. In 2013 the Friends shifted their focus to general fundraising to support park operations.

The Friends are also working to market the parks through a developing relationship with Greater Lansing Convention and Visitors Bureau (GLCVB). The Friends have initiated a membership with GLCVB and have placed an advertisement for the parks in the 2013 annual visitor guide. Building an increased presence in the community through partnerships, speaking engagements and networking is planned.

4. Do you plan to enhance or reduce any of your department's services?

Department staff will strive to continue providing quality service to park visitors. The Ingham County Parks provide a diverse group of activities and additional services are not planned. Reduction of services is dependent upon funding and staffing levels. As noted above, possibly closing parks 1-2 days per week, shorter park and office hours, eliminating 508 enterprise activities, further reducing park maintenance, eliminate free picnic shelters for youth groups, eliminate fish stocking which directly impacts several fishing events in the parks.

5. Do you anticipate any significant increase or decrease in demand for your department's services? Please indicate those areas that may be affected.

We anticipate consistent visitation levels in the Ingham County Parks. We attribute the slight decrease in visitation from 2011-2012 to increased entry fees and the daily collection of fees at Hawk Island, Lake Lansing South and Lake Lansing North.

Maintaining additional facilities including the Hawk Island Snow Park, the River Trail South segment between Potter Park Zoo and Hawk Island, and the Soldan Dog Park places more demand on staff time and the parks budget.

Two key determinants are weather and gas prices. Both factors are completely beyond department control. Increased gas prices are potentially good for the County Park system while poor weather be it too rainy, to cold, to hot, to windy, to humid or a lack of snow can all impact visitation levels, need for services and financial outcomes.

6. Are there any comments or observations that you would like to speak to that are not covered above?

Historically, the Ingham County Parks have not engaged the concept of fundraising as a means of funding the parks. The Parks Department will be working in conjunction with The Friends of Ingham County Parks and the Parks and Recreation Commission to build a stronger fundraising unit. All three groups; the Friends, park staff and the Commission are in mutual agreement regarding the importance of developing and building the role the Friends play in regard to funding for the parks.

The Ingham County Parks Commission is supportive of engaging other governmental units in a regional relationship regarding parks and the possibility of a regional park millage. The parks and trails to benefit from such a millage would need to be clearly

outlined beforehand presenting the question to voters. Ideally a potential millage would not simply replace the current county appropriation with millage but place the Ingham County Parks on a track to increase funding.
