The Ingham County Parks & Recreation Commission held a Regularly Scheduled Meeting at the Human Services Building, Conference Room A, 5303 S. Cedar Street, Lansing, Michigan.

Call to Order:	Chair Nicholls called the Regularly Scheduled Parks & Recreation Commission meeting to order at 6:02 pm

#### **ACTION ITEMS**

Willis Bennett provided background information regarding the resolution recommending authorizing utilizing grant matching funds for the Lake Lansing Park-South beach house renovation project.

#### **RESOLUTION #07-14 RESOLUTION RECOMMENDING AUTHORIZATION TO UTILIZE GRANT MATCHING FUNDS FOR THE LAKE LANSING PARK-SOUTH BEACH HOUSE RENOVATION PROJECT**

**WHEREAS,** Park staff applied for a 2013 DNR Recreation Passport Grant for renovations to the Lake Lansing Park-South Beach House and the grant was not approved by the DNR; and

**WHEREAS,** the existing building is over 35 years old, serves over 200,000 park visitors each year and requires structural and mechanical upgrading to protect the integrity of the building and ensure visitor safety; and

**WHEREAS**, in the Parks 2013 Capital Improvement Budget, \$15,000 was approved as matching funds for the Recreation Passport Grant; and

**WHEREAS,** Park staff desires to complete a portion of the renovation project in 2014 and recommends that approved matching funds still be used for the renovations.

**THEREFORE BE IT RESOLVED**, that the Ingham County Parks & Recreation Commission recommends that the Ingham County Board of Commissioners authorizes the \$15,000.00 approved for the match for the 2013 Lake Lansing Park-South Recreation Passport grant application be utilized for the project.

Moved by Mr. Czarnecki and Supported by Mr. Monsma that Resolution #07-14 be approved. Yes-6; No-0. MOTION CARRIED.

#### **DISCUSSION ITEMS**

<u>March 2014 Financial Report</u> ~ Willis Bennett referenced the report in the packet. Mr. Czarnecki pointed out revenue was down in January for Hawk Island due to the bitterly cold weather and there wasn't as much traffic in the park. In future months we hope to see an increase in parking revenue.

<u>2015 Budget Request</u> ~ Willis Bennett stated the budget request will be presented at the May park commission meeting.

Mr. Pratt entered the meeting at 6:13 pm.

Willis Bennett stated for 2015, the budget request is to add funding to 508 to offset full-time wages currently charged, add sheriff deputy patrols to all parks, add additional funding for maintenance supplies, and add additional funding for seasonal maintenance labor. The Parks Department is requesting full time labor be charged to 208 as it had been several years ago. Providing deputies in the park will provide a better customer service experience.

Mr. Duffy entered the meeting at 6:14 pm.

Additional funding for maintenance supplies would allow the Parks Department to purchase fertilizer, weed control, paint and other supplies. Adding more seasonal staff would improve the appearance of the parks. At this time, we are not in the position to ask for a full time staff member, in 2016 this could be requested. Mr. Czarnecki inquired if the capital improvement request document on page 13 of the packet was listed in order of preference. Willis Bennett stated park staff worked on this list and it is in order of preference. Willis Bennett stated the Ingham County Parks Master Plan is good through 2016 and can be reviewed next year for updating.

<u>December Committee Meeting Schedule</u> ~ Mr. Czarnecki stated the December budget committee meeting has been cancelled.

Chair Nicholls stated the September 22, 2014 park commission meeting will be held at Lake Lansing Park-South instead of the Human Services Building.

<u>Meridian Township Deer Hunt in the Lake Lansing Park-North</u> ~ Park Manager Pat Witte reported on the Meridian Township deer hunt. The car-deer accidents rose despite this program. Most of the car-deer accidents are on Grand River. Mr. Witte reported this was a successful program and there were no complaints regarding the program.

<u>*Task Force Update*</u> ~ Willis Bennett stated the last task force meeting was on April 9th and the next meeting is scheduled for May 5th. Discussion ensued about the questions and concerns the task force raised at the last meeting.

#### **DIRECTOR'S REPORT**

<u>Hawk Island Snow Park Status Report</u>~ Willis Bennett stated the Magic Carpet® will be removed by the contractor and the County does not have to pay for the Magic Carpet®. Willis Bennett stated he is working with the Controller's office to reach out to snow resorts in the state of Michigan to inquire if there is any interest in operating the terrain park. If there is enough interest, a request for proposal will be released.

<u>Other</u> ~ Mr. Witte stated there were 126 volunteers in the month of April at Lake Lansing Parks, ranging from students from Michigan State University, high school students from Detroit, and high school students from Lansing Catholic Central.

The prescribed burn at Lake Lansing Park-North was a success on the three ten acre plots.

#### **RESOLUTION MODIFYING THE SPECIAL EVENT POLICY**

**WHEREAS**, the Ingham County Parks Department has received multiple requests from park visitors who request permission to rent an inflatable bounce house or a rock climbing wall from an outside vendor, and it is necessary to add language to the Special Event Policy in order to provide language facilitating these activities; and

**WHEREAS**, the Michigan Municipal Risk Management Authority has identified the specific risks for such events and recommended appropriate insurance requirements; and

**WHEREAS**, an inflatable bounce house rental from an outside vendor should be classified as a Class II event in the Ingham County Parks Special Event Policy, with \$1,000,000 minimum combined single limit insurance coverage requirement; and

**WHEREAS**, a rock climbing wall from an outside vendor should be classified as a Class III event in the Ingham County Parks Special Event Policy, with \$3,000,000 minimum combined single limit insurance coverage requirement.

**THEREFORE BE IT RESOLVED,** the Ingham County Parks and Recreation Commission recommends the Special Event Policy be revised to include language as stated above for insurance requirements for an inflatable bounce house rental and rock climbing wall from an outside vendor.

#### <u>RESOLUTION RECOMMENDING THE SIGNING OF A ROAD ASSESSMENT PETITION FOR</u> <u>THE PAVEMENT OF A GRAVEL PORTION OF PERRY ROAD</u>

**WHEREAS**, Ingham County owns property in Meridian Township with 535 feet of road frontage on Perry Road; and

**WHEREAS**, the Lake Lansing Special Assessment District Advisory Committee (SAD) has identified this gravel road as a source of sediment that flows into Lake Lansing; and

**WHEREAS**, the SAD has recommended to Meridian Township that Perry Road be paved in an effort to continue their work in improving the health of Lake Lansing and its watershed; and


**WHEREAS**, Meridian Township will petition the land owners along Perry Road in regards to a special assessment district to finance the project; and

**WHEREAS**, if assessed, the County's assessment is estimated at \$10,000 which equates to the approximate 36% of road frontage the County owns on Perry Road; and

**WHEREAS**, the Ingham County Parks Commission supports the project concept and the work of the SAD and recommends that the Ingham County Board of Commissioners agrees to and signs the Perry Road Assessment Petition; and

**WHEREAS**, the Parks Commission will recommend funding for the assessment in the Parks Department's 2015 Capital Improvement Request.

**THEREFORE BE IT RESOLVED**, the Parks & Recreation Commission recommends that the Ingham County Board of Commissioners authorizes the Board Chairperson to sign the Perry Road Assessment Petition and agrees to pay the assessment if levied by Meridian Township.

**RE: Perry Road** 

Dear Mr. Bennett:

In order to fund improvements for Perry Road between Lake Drive and the county limit, Meridian Township has prepared a petition to defray the cost amongst property owners with frontage along said gravel road. The improvements will include sub-base, base, drainage improvements and installation of asphalt surface. The work may also include paved shoulders for non-motorized users.

Our original estimate for the entire project is \$30,000, with the county's share estimated at \$10,027 based on frontage constituting 36.46% of the total road frontage within the proposed assessment district.

So far we have signatures from property owners representing 45% of the entire project frontage; a valid petition must have signatures from property owners representing at least 50%+ of the total frontage.

We understand that the county would be willing to sign the petition provided that their monetary assessment is reduced by the value of the in kind field work performed by the County Road department. Meridian Township is agreeable to this concept and would like for the county to sign the petition accordingly.



#### FACT SHEET

#### Perry Road PAVING SPECIAL ASSESSMENT DISTRICT

The proposed design is a 22' wide asphalt pavement. The work will also include all necessary grading, ditch modifications, and drainage improvements. The pavement will extend along Perry Road from Lake Drive north to the County line. The length of pavement will be approximately 535'.

A public hearing conducted by the Township Board will follow a successful petition.

The estimated cost of the road pavement and related work is \$30,000. The Lake Lansing watershed SAD will contribute \$2,500 towards the project. Assessments will be proportional to the frontage of the property.

Final assessments would be based on actual construction cost.

The assessment may be paid in full, or over a period of several years at 5% interest. The pay back period is established for 10 years, but it may be longer if approved by Township Board. The first payment to the Township will be due July 1, 2015.


