OLD BUSINESS

Emergency Egress Completion

Mr. Terrill said they are at a point where the City of Lansing is just about done with the Allen Street Egress, as they are waiting for them to finish up the asphalt and then will need to finish leveling the gate. Then they will review the Emergency Evacuation Protocol.

Mrs. Wagner said there is a plan for the animals to be moved during an emergency evacuation.

Search Committee Update

Dr. Snider said they were given nine resumes and will narrow them down to five people. They should be able to make the October 31st deadline.

Presentation of Board Roles and Responsibilities

Mr. Nordfjord introduced himself and stated he is one of the County's Attorneys. He talked about the guidelines of the County Boards. He talked about quorums, closed sessions, Open Meetings Act, and how the boards report to the BOC. He also spent some time looking over the minutes and says they look good. He also said the source of the Board is a resolution that created the Potter Park Zoo Board and this will need to be updated as you no longer report to the Parks Department. He knows there are no Bylaws, but they may decide to create some and he can help out that if you would like him to.

Commissioner Nolan stated that the Society does not have an unstaffed attorney, but if they ever legal questions or issues they can use the County's Attorneys. They are a great team.

Commissioner Koenig arrived at 6:25 PM.

Commissioner Nolan wanted to point out this is an Open Meeting and need to place a sign out front in regards to the meeting.

Discussion of Zoo Hours

Mrs. Wagner talked about the zoo hours and wanted to know if it's worth staying open later than 6:00 PM and also about opening early. On the survey, people said they would like to see the zoo open later on Friday evenings, so this maybe something to consider too. They've received a lot of complaints on the survey about not enough animals being out when the gates open. It's hard when the keepers arrive at 8:00 AM and then try to have animals out by 9:00 AM when the zoo opens, so she is working on some things to alleviate this issue for next summer.

Chair Groen asked if Mrs. Wagner could look at Cincinnati and New Zoo to see it's worth it for them.

Resolution Recommending Acceptance of a \$3,800 Monetary Gift from the Potter Park Zoo Docent Association for a New Barred Owl Enclosure Resolution #16-04

WHEREAS, the Potter Park Zoo Docent Association collects member dues annually and sells crafts to raise funds; and

WHEREAS, the Potter Park Zoo Docent Association votes at monthly meetings on the organization(s) they would like to donate a portion of those funds to; and

WHEREAS, the Potter Park Zoo Docent Association voted to donate \$3,800 of these funds to the Potter Park Zoo for the specific purpose of building a new Barred Owl enclosure; and

WHEREAS, a new Barred Owl enclosure is needed to improve the housing of the current Barred Owl; and

WHEREAS, the Barred Owl enclosure will be built in the North American section of the Zoo aligning with the current Zoo Master Plan; and

WHEREAS, \$3800 will cover the cost of the exhibit in its entirety based on a quote from the Ingham County Facilities Department; and

WHEREAS, the exhibit will be constructed by the Facilities Department utilizing in-house labor.

THEREFORE BE IT RESOLVED, that the Ingham County Board of Commissioners accepts the donation of \$3,800 from the Potter Park Zoo Docent Association to be used for building a new Barred Owl enclosure at Potter Park Zoo.

BE IT FURTHER RESOLVED, that the Controller/Administrator is authorized to make any necessary budget adjustments consistent with this resolution.

BE IT FURTHER RESOLVED, that the Ingham County Board of Commissioners would like to thank the Potter Park Zoo Docent Association for this generous gift.

Moved by Dr. Snider and Supported by Commissioner Koenig that resolution #16-04 be approved. (Yes-6; No-0). MOTION CARRIED.

Mrs. Wagner stated in the spring of 2016, the members voted to support the zoo by providing funding for an improved Barred Owl enclosure in the North American area of the zoo near the otter and wolf exhibits. With the changes that occurred in the director position at Potter Park Zoo in early spring, this project was put on hold and we feel we are now able to move forward.

DIRECTOR and FINANCIAL REPORTS

Zoo Director's Report

Mrs. Wagner said Mr. Tissue turned his resignation in and will done as of October 21, 2016; the flood insurance has increased for 2017; evaluating the keeper injuries as there have been a lot of bites lately; very busy with shipments such as otters and acquiring kangaroos; and the Red panda babies were let out and one got his head stuck in the fence, so will wait a couple of weeks before letting them back out.

August Financial Report

Ms. Rhode introduced herself as the Director of Financial Services and stated that Delphine Breeze will be the person giving this report from now on. She talked about how the zoo receives all of their money at the beginning of the year. This report is as of August 31st and next month, they will have September and October. She talked about the second page of the balance sheet and how there is a depository of monies and how they need to be transferred to the County faster. She said the zoo will look better this year because usually there is an expenditure made to the Society in the fall and that will not be happening this year. She also said traditionally the revenues are budgeted too high. She also said they need the fund balance to be at a higher balance. She said overall the zoo looks good.

Zoo Director Report 11-10-16

I am very grateful and excited to have been presented with the opportunity to lead Potter Park Zoo into a time of continued growth and success in the zoological community and our local community.

Top 4 Priorities

1. Staff

- Hire 4-5 public safety employees for ranger and desk positions. This is an immediate need to allow us to provide 24/7 hour coverage.
- Hire a General Curator within the next 4 weeks. The position has been posted and plan to schedule interviews the week of November 28th.
- All staff meeting on November 16th
- 2. Evaluate 2016 budget and make any additional adjustments needed in November and December.
- 3. Collaborate with the County Controller to bring a resolution to the Board establishing the agreement between the Zoological Society and the Potter Park Zoo as well as other policy and procedural resolutions.
 - Define the functions of each entity including how events will be structured.
 - Complete the concessions RFP with the County Purchasing Department to determine if the restaurant and gift shop will be run be a vendor or in house.
 - Complete job descriptions and budget for positions transferred from the Society to the Zoo; Guest Services Manager; Parking/Admissions Lead as well as parking and admissions attendants; Animal Care, Restaurant and Gift Shop seasonals.
 - Propose a rate and/or hour changes for 2017.
 - Present recommended Zoo rules and regulations for zoo visitors.

4. 2017 AZA Accreditation

- Examine the newly posted 2017 AZA accreditation standards.
- Determine a priority list for all standards and items not currently in place or in process.
- Inspect the zoo with the maintenance team and prepare a priority list of maintenance work orders
- Organize completed documents for the application with the registrar.

Animal Management

- 1. North American River otters- Shipments are almost complete, 1.0, Clyde was transferred to Roger Williams Zoo. We will be introducing the new breeding female to our male in the next two weeks.
- 2. Ponies the mare involved with throwing off a child this past summer, is being placed out to a family in Greenville, MI.
- 3. Meerkats- We are acquiring a group of 4.1 from Disney after permits have been completed.
- 4. Barred owl The new Barred owl exhibit will be completed soon by the County carpenter with assistance from PPZ's Facilities staff. The money donated from the PPZ docent association made this exhibit possible. We are still discussing what we to do with the empty corn crib from which the owl is being moved from.
- 5. Tenrecs 0.2 tenrecs were dispositioned to Blank Park Zoo per SSP recommendations.
- 6. Black rhino- The pre-ship exam was completed on the male black rhino in Caldwell, TX. After results come back, a final determination will be made on the transfer. Chris Danhauer has committed to being the transporter for the transfer when we move forward.
- 7. Western Garter snakes The exhibit is complete for the Western Garter snakes in the Bird and Reptile Building.
- 8. Binturong We have committed to receiving a breeding pair per SSP recommendations.
- 9. Kangaroo We are waiting for final SSP recommendations to acquire a group of red and grey kangaroos.
- 10. Emu We will be bringing in 1.1 emu in the spring to exhibit with the kangaroos.
- 11. Giant Anteater We are working with SSP to determine the best animal to transfer to PPZ. The Giant Anteater will be exhibited in the old kangaroo yard closest to the restaurant.

BACKGROUND

The Lansing Lions Club offers support to local organizations through ongoing commitment to community needs. In 2011, the Lions club selected creating a sensory garden at Potter Park Zoo as their top priority for future community commitment. This garden is a symbol of a legacy of service that honors those who have created a tradition of service within the Lions Club and also is a place any visitor, regardless of age or physical ability, can enjoy the natural environment. Phase one was completed in 2012 and phase two followed in 2013 with the addition of three sculptures. Regular upkeep of the garden has been maintained by Lions Club members and the garden continues to be place visitors can enjoy the natural environment.

FINANCIAL IMPACT

None. The Lansing Lions Club has raised all of the funds necessary to build the waterfall and will oversee its construction. Further, they have committed to all future maintenance of the waterfall through volunteer hours provided by the Club's members.

OTHER CONSIDERATIONS

This waterfall will be constructed along the main path of the zoo near the Wings Down Under Exhibit and will be a tremendous improvement to the landscape. This is an area of zoo grounds that does not currently have any plans for development other than the placement of the waterfall.

RESOLUTION AUTHORIZING ACCEPTANCE OF A DONATION FROM AND TO ENTER INTO A CONTRACT WITH THE LANSING LIONS CLUB FOR THE ADDITION OF A WATERFALL TO THE LIONS CLUB SENSORY GARDEN AT POTTER PARK ZOO

WHEREAS, the Lansing Lions Club installed and has maintained a sensory garden on the South East corner of the zoo attached to the Wings Down Under interactive exhibit for many years; and

WHEREAS, the Lansing Lions Club has planned to include a waterfall in the sensory garden along the main zoo path by the Wings Down Under entrance; and

WHEREAS, the Lansing Lions Club has raised the necessary funds for the specific purpose of building a waterfall in the sensory garden at Potter Park Zoo which will enhance the experience of zoo visitors; and

WHEREAS, the Lansing Lions Club will supply all materials and labor to complete the installation of the waterfall; and

WHEREAS, the Lansing Lions Club will provide for the future maintenance of the waterfall including associated maintenance costs; and

WHEREAS, neither Potter Park Zoo nor Ingham County will bear any costs associated with the construction, maintenance or liability of the waterfall;

THEREFORE BE IT RESOLVED that the Potter Park Zoo Board accept the donation of a completed waterfall from the Lansing Lions Club to enhance the sensory garden at Potter Park Zoo.

BE IT FURTHER RESOLVED that the Potter Park Zoo Board and Ingham County Board of Commissioners wishes to thank the Lansing Lions Club for their generous donation to Potter Park Zoo.

BE IT FURTHER RESOLVED that the Ingham County Board of Commissioners authorizes the Board Chair to sign a contract and any necessary documents that are consistent with this resolution and approved as to form by the County Attorney.

Lansing Lions Club Sensory Garden Planning and Progress Report September 25, 2016

On September 23, 2009 the Lansing Lions Club adopted the Position Statement of Mission and Goals, in which it made a significant change of direction in its pursuit of service to the Greater Lansing community. "As a consequence of this change in practices...the club (will) become more effective in its narrowly focused mission. The effect of this would be to offer our support, on the basis of ongoing commitment, to...community needs unrelated to vision care."

In the ensuing two-year period the Lions Club considered a number of alternative community service projects which could become the focus of all future contributions. Finally, in a statement of our new direction we adopted the Sensory Garden at Potter Park Zoo as the top priority for the future. The announcement described the intent of the project and invited support from any interested parties, summarized with the following statement.

In more than ninety years of existence, the Lansing Lions Club has performed numerous services for the Lansing community. Generations of our citizens – those in need of assistance, young and old, blind and visually impaired – have all benefited from the many projects supported by our members.

We are now in process of establishing a new type of contribution to the community that will create a symbol of our legacy of service. At the same time, this new project — **Lansing Lions Club Sensory Garden** — will honor those who helped establish our tradition of service.

In cooperation with Potter Park Zoo we are creating a Sensory Garden to make it possible for anyone, regardless of age or physical ability, to enjoy the natural environment features on display. Those with impairments of mobility, vision, or other senses will be accommodated by the design of the garden.

By September 18, 2012 the newly completed first phase of the Sensory Garden was dedicated in a ceremony held on the grounds of the Potter park Zoo. This would be followed by a second phase, the following year, that included the addition of three sculptures acquired through a grant provided by the City of Lansing and Leap as a part of its "Sense of Place in the Arts" grant program, and in cooperation with Potter Park Zoo.

Now the Lansing Lions are entering the third phase of the sensory garden development. This will involve expansion of the site to include a pond with waterfall and adjoining stonework. Construction of this waterfall project will involve excavation of the area, tree removal, electrical installation, and placement of boulders and stacked stones. The project is planned to be completed by the Spring of 2017 at an estimated cost of \$20,000.

The Lansing Lions Club has expressed its commitment to community service since 2010 through concentrating its efforts on the creation and development of a sensory garden on the property of the Potter Park Zoo. A sensory garden provides for a variety of static and dynamic features - plants, sculptures, and flowing water – each of which offers a stimulus to one or more senses. In this way all visitors, including those with impaired vision or other limitations may enjoy the experience of the smells, sounds or tactile sensations offered by the garden.

Now the Lions of Lansing are entering the third phase of the sensory garden development. This will involve expansion of the site to include a pond with waterfall and adjoining stonework. Construction of this waterfall project will involve excavation of the area, tree removal, electrical installation, and placement of boulders and stacked stones. The project is planned to be completed by the Spring of 2016 at an etimated cost of \$20,000.

In addition to the Lions' ongoing fund raising efforts we are seeking financial assistance from interested community resources and private enterprises in the Greater Lansing area. We are hopeful that, through the combination of work done by Lions Club and zoo staff and the added financial support of contributors, this unique facility will continue to grow and serve people of all ages who may visit the Lansing Lions Sensory Garden in years to come.
