OLD BUSINESS

Moose Exhibit Update

Mrs. Graham said we are waiting for the City Planning Commission. She said both moose are together now and getting along and he has a name "Meeko."

Commissioner Nolan asked if every time we do something we do have to go through the City.

Mrs. Graham said yes.

Commissioner Tsernoglou asked does the City want to give the park to the County.

Commissioner Nolan said any time a park can be given to a developer or the County it is by the vote of the people.

Mrs. Leys asked if the City would want to be paid for it.

Mrs. Graham said it would make life easier.

Mr. Kibbey said all the discussions were in regards to the management of the zoo.

Strategic Planning Update

Chair Groen said he and his wife facilitated two sessions at the zoo which were a lot of fun. The results were three initiatives; one is to increase the size of the budget and there are a lot of strategies on how to do that; the second one to improve the environmental responsibility to improve the carbon foot print and lower waste down to 0%; and the third is is becoming a leader in conservation both in the field and at the zoo, educating visitors about our collection; and their native habitat. Eventually, there will be a written plan.

NEW BUSINESS

2016 Proposed Fee Increases

Mrs. Graham said they received a form from the County using a rate of 1.6% increase. They went through and collaborated with the Parks Director to maintain equity with the County Parks rates. We will increase the children's amount by \$1 and the winter rates by \$1. She went over all the columns entered what they thought the rates should be how much additional revenue would be generated and then give reasons for on staying the same or raising the rate.

ZOO DIRECTORS REPORT

Mrs. Graham talked about her written report. The zoo is gearing up for the beginning of the official season which starts April 1st. They received the first installment from the Glassen Foundation. The Society Board approved a full time position dedicated to raising funds and promoting advocacy for the zoo. She said they had to fill out a survey for sponsorships received for AZA for 2014 which ended up being around \$80,000. Had a farewell luncheon for Keeper Jan and she wanted her farewell gift to go to creating a new look at the front of the North American Exhibit. Mark Marquardt will be leaving on April 1st and he is a keeper. The Zookeeper positions have been filled and she is now in the process of looking at applications for Zookeeper Aid positions. The new structure is all set to start April 1st. The construction on the Red Panda exhibit will start in April and the resolution will be at County Services on this upcoming Tuesday. Finally, found something that the squirrels won't eat on the raven exhibit, so that will be in place and when it is tacked down securely the ravens will be released. The Mission Statement has been changed and is the one that is used the most for grants and everyone was in agreement. It was better we have a new membership card which looks very nice. There's a meeting with Mr. Berghorn and the Green Team on Friday. We are out of office space and DBI is coming in and putting a work station in the kitchen and another one in the AV closet. There are two new moms and now we are redoing the bathroom into a Lechie Lounge so at least there is a comfortable space for them. In keeping with the conservation theme, we ordered recyclable bags to replace the plastic bags for the gift shop.

FINANCIAL REPORTS

Mr. Wingeier said there is a few things to bring to your attention, the revenue looks bad, but isn't that bad. On item A, salaries & wages, is the same as last year. Item B, there was less animal lab work and medicine purchased than last year. Item C, a pipe burst in the Animal Clinic resulting in a major flood. The cleanup is hitting the purchased services account hard, but all but \$1,000 should be reimbursed through the County's insurance. Item D, the County changed the classification of CIP items to project of \$5,000 and up as opposed to the previous classification of \$1,000 and up. The smaller CIP items are now expensed in the departments budget's instead of the CIP budget. Item E, last year the insurance was paid monthly, but this year it was paid in one lump sum in February. He then talked about the attendance. He also said he has included the Society financials and gave an overview.

BOARD COMMENTS

Mrs. Leys said she did go to the Arbor Society of Michigan Conference and attended a lot of sessions. She went to a couple on Oak Wilt and it is a fungus disease that plugs up the vascular tissue of the tree especially with Red Oaks. It can kill in a matter of a few weeks. White Oaks are a little bit more resistant. As she was walking up the walk, she saw both at the zoo. She wants to have a moratorium at the zoo on any pruning or damage on oaks from April to July. There are little beetles that spread the fungus around during that time. She thinks there should be some type of zoo policy. It is best to prune Oaks in the winter and once it is found on the property, it is very hard to get rid of.

Mrs. Graham asked if there is a test for Oak Wilt.

Mrs. Leys said yes, there is if you would send samples in. The DNR is really into this.

RESOLUTION AUTHORIZING A TRANSFER OF CAPITAL IMPROVEMENT FUNDS TO THE WOLF EXHIBIT PROJECT

WHEREAS, Potter Park Zoo has made modifying the Wolf Exhibit its highest priority Capital Improvement Project item to accommodate the two new wolves the Zoo has received.

WHEREAS, the Zoo would like to request a line item transfer of the balances from the Pathway Replacement Phase I Project, line item #258-69900-977000-1501Z with a balance of \$25,917.00 and the Birdhouse North Exhibit Repairs Project, line item #258-69900-977000-1502Z with a balance of \$50,000.00 to the Wolf Exhibit Project, line item #258-69900-977000-1514Z.

WHEREAS, once the above transfers are complete, the funds for the Wolf Exhibit Project will be available in CIP line item #258-69900-977000-1514Z, which will have a balance of \$75,917.00.

THEREFORE BE IT RESOLVED, that the Potter Park Zoo Board approve the transfer for a total of \$75,917.00 from the above mentioned accounts into the approved Wolf Exhibit Project, CIP # 258-69900-977000-1514Z bringing the total balance in that account to \$75,917.00.

BE IT FURTHER RESOLVED, the Controller/Administrator and the Chair of the Board of Commissioners be authorized to make the necessary transfer of funds.

A 600 Level Zookeeper retired and was replaced by a Temporary Zookeeper, resulting in an increase in the Salaries & Wages - Seasonal line item compared to 2014.

® Animal Care:

Less animal lab work and medicine was purchased in March 2015 than in March 2014.

© Purchased Services:

A frozen pipe burst in the Animal Clinic, resulting in major flooding. The clean up and repairs related to this incident have been charged to Building Repair and Maintenance, classified under Purchased Services. 


