#### ENVIRONMENTAL AFFAIRS COMMISSION March 23, 2022 Draft Minutes

The meeting was called to order by Commissioner Trubac at 5:30 p.m. in Conference Room D/E of the Human Services Building, 5303 S. Cedar Street, Lansing Michigan.

#### Approval of Draft Minutes

Nowicki motioned, Biber seconded to amend the minutes to reflect recent changes in the law regarding virtual participation at meetings. The motion passed.

The minutes from January and February were approved.

#### Limited Public Comment

Elaine Fischhoff gave comment regarding: 1. She would like the Environmental Commission to be listed on the county website and for minutes to be made available there. 2. The county fleet could be electrified. 3. The commission could explore the creation of an EV network 4. She would like to see environmental justice projects to assist low income or otherwise disadvantaged communities.

3. Lansing Environmental Action Team (LEAT) (Presentation/Discussion)

Members of the Lansing Environmental Action Team Marshall Clabeaux, Randy Dykhuis and Elaine Fischhoff gave a presentation detailing the history of the group and outlining what changes they would like to see implemented in the county. They referenced a model being used in Oakland County. Some of the priorities included:

- Lowering emissions to make buildings more efficient
- Making it easier to utilize alternative modes of transportation
- Scheduling speakers at each meeting to assist in informing the commission
- Hiring someone to a position that would oversee the implementation of further action
- Commit to using ARP dollars for meeting climate goals
- Hold GM accountable for running new operations on renewable energy

Biber spoke to increasing native plantings as a first step that would increase biodiversity and energy efficiency.

Cowels spoke in favor of scheduling a speaker for future meetings and in exploring the possibility of a staff position.

MOVED BY COWELS, SUPPORTED BY BIBER TO DIRECT STAFF TO BEGIN PRELIMINARY RESEARCH INTO THE FEASIBILITY OF A NEW POSITION TO OVERSEE ENVIRONMENTAL POSITIONS IN THE COUNTY.

#### Energy Audit Services

Ingham County entered into a contract with Bureau Veritas Technical Assessments, LLC to conduct an energy audit on 16 facilities/sites. The contractor will do an energy audit and report for each facility including:

- Heating, ventilation and air condition (HVAC) equipment including humidity control
- Energy management and control systems
- Lighting
- Water Usage
- Domestic hot water
- Building envelope including insulation
- Other energy systems
- Greenhouse gas emissions
- Ground keeping






- Energy Audit Services Deliverables
  - The results of the audit will allow the County to implement green building practices, pollution prevention strategies, and to reduce the overall environmental impact of County building operations.
  - Ingham County Parks would also be upgrading outdoor lighting at winter sports facilities at Hawk Island and Burchfield Park with more efficient lighting.





- Enhance the sustainability of our landscapes
  - 1,200 acres of park land
  - 90% is natural area
  - Reduce mowing in the parks only 10% of park system
  - Utilizing native plantings on edges/fringe areas






- With the majority of new projects, we are incorporating more environmentally friendly designs such as bioswales and rain gardens






## Construction of a Natural Shoreline Protection Project at Lake Lansing South



- Bioengineering is a method of stabilizing shorelines with shrubs, herbaceous plantings, and natural materials to prevent erosion and provide fish and wildlife habitat
- Will be used as a demonstration plot for residents of Lake Lansing to encourage installation of natural shorelines on their properties





## Natural Shoreline Protection Project at Lake Lansing South



### Ecological Benefits

- Natural wave energy absorption
- Provides critical habitat for fish and wildlife
- Filters run-off
- Promotes percolation
- Deters nuisance geese





## **Green Our Rides**

- Ingham County will work to transform our existing fleet/equipment and adopt greener transportation and maintenance methods
  - Electric vehicles are a green and efficient option
  - Battery/electric utility vehicles and various equipment –i.e. mowers, chainsaws, weed whips, etc.





## Alternative Transportation Methods & Recreation



- The County Trails and Parks Millage encourages alternative modes of transportation by investing in trail systems to make regional connections
- Due to many varying user groups, we try to provide for both passive (wooded, not mowed, birdwatching, etc.) and active (beach front, picnic areas, places to throw ball, etc.).
- We have a good balance of passive vs active recreation areas within our parks
  - We have such high usage compared to acres maintained. For example, Yosemite has 4 million visitors for 750,000 acres whereas Ingham County Parks has over 2 million visitors for only 1,200 acres.

## Alternative Transportation Methods & Recreation



#### Analysis: Increasing the Bicycle and Pedestrian Share of Trips

At present, one-third of all trips less than 1 mile are made by walking and bicycling, while two-thirds of all trips less than 1 mile are made by cars, trucks and motorcycles. Eight percent of all 1- to 3-mile trips and 2% of all 3- to 5-mile trips are made by walking and bicycling (i.e., 10.6 billion and 3.5 billion miles of active transportation, respectively), while 88% of all 1- to 3-mile trips and 93% of all 3- to 5-mile trips are made by cars, trucks and motorcycles (8 billion miles).<sup>51</sup>

- Increasing the bicycle and pedestrian share of trips less than 1 mile from 33% to 50% under a modest scenario, and from 33% to 62% under a substantial scenario, would result in 21 billion and 26 billion driven miles avoided, respectively.
- Increasing the bicycle and pedestrian share of 1- to 3-mile trips from 8% to 10% under a modest scenario, and from 8% to 14% under a substantial scenario, would result in 18 billion and 26 billion driven miles avoided, respectively.
- Increasing the bicycle and pedestrian share of 3- to 5-mile trips from 2% to 3% under a modest scenario, and from 2% to 6% under a substantial scenario, would result in 5 billion or 11 billion driven miles avoided, respectively.

This analysis includes short trips of 3 miles and medium length trips of 3–5 miles to better reflect experienced and inexperienced bicyclists. Experienced bicyclists routinely travel 5 miles or more per trip, while inexperienced bicyclists generally travel 3 miles or less per trip.<sup>52</sup>

Estimates of modest and substantial scenarios for walking/bicycling trip length are based on the following assumptions:


- The modest scenario was calculated by averaging the top 25 states' (for walking and biking) percentages of walking/bicycling in that trip's mileage category.
- The substantial scenario was calculated by averaging the top five states' (for walking and biking) percentages of walking/bicycling in that trip's mileage category.












